Facility Information: USTA Billie Jean King National Tennis Center, Flushing Meadows, Queens. Showers and lockers are available, water will be provided to each player as well as available on the courts, and a light breakfast will be available to players.

Directions: Take the #7 train to Willets Point/Shea Stadium in Queens and follow the boardwalk to the National Tennis Center. Visit <http://travel.mtanyct.info/serviceadvisory> (MTA website) for updated service advisories. Call the USTA NTC at 718.760.6200 for driving directions.

Confirmation: An e-mail confirmation (or phone call) will be sent within 48 hours of receipt of application. A final confirmation letter, with tournament details, will be sent on May 22nd. Play begins at 8:00 a.m. on May 26th.

Seeding: Seeding will be determined using current GLTA rankings.

Scoring: All men's and women's singles and doubles matches will the best 2-out-of-3 sets. A 12-point tiebreak will be played at 6-all. Mixed doubles will play a 10-point super-tiebreak in lieu of a third set. **Modified scoring may be used at the discretion of the tournament directors.**

Draws: Refunds will not be given after the draw is made on May 22, 2012.

Schedule: Tournament officials will make every effort to notify players of scheduled match times. Players are responsible for knowing these match times. Please contact the tournament desk if you have a last-minute problem.

Consolation Matches: Consolation play for first match singles losers will be available. The format is an 8-game pro set, no-ad scoring, for all rounds except for the Final. The Final will be a best 2-out-of-3 sets. It is the player's responsibility for getting the match start times which will be posted at the tournament desk.

Cancellations: The tournament directors may combine or cancel divisions if less than four (4) players or teams sign up for a division. Entrants in a division being combined will be offered a refund if they choose not to play in the new division.

Conditioning: Please be advised that if you enter more than one event, you will be required to play multiple matches with minimal resting time between matches. Please consult with a physician if you feel you are at risk of heat or physical exhaustion, as MTG cannot be held responsible for injuries.
